The Town Clerk informed members that at the meeting of the Amenities Committee held on 13<sup>th</sup> August, the Town Council's grant funding budget was briefly discussed. It was suggested that BID Camborne might want to prepare and submit a draft plan of their expected grant funding requests by November, to give the Town Council advance information when setting the budget for the next financial year. This had now been received and their estimate was £10,000.

The Chairman and Vice Chairman made the decision to delay the decision made at the last Amenities meeting, to write to Cormac regarding the half painted lamp posts, to obtain a completion date for finishing the work A.3578; until after the dismantling of the town's floral arrangements.

**A.3586 TO RECEIVE THE CURRENT NET POSITION BY CODE FOR THE AMENITIES BUDGET 1015/2016**

The Town Clerk informed members that there would be an overspend on cost code 45 Deputy Handyman's Salary following the Council's decision to make the position full time; the Finance Committee would provide the extra funding to cover it.

Cost code 60 Street Furniture, had a committed expenditure of £1,123 for the WW1 Commemorative bench at Killivose Cemetery.

Cost code 66 Small Works, was for maintenance and work on the Fountain and the Town Clock.

£4,945 of the £5,000 in cost code 68 Christmas in Camborne, had already been committed as the costs of the Lantern Parade.

Of the Amenities Earmarked Reserves budget £3,000 had been committed to the purchase and installation of a new notice board for Barripper village; the notice board had arrived and Cormac would be installing it soon.

The funds remaining at the end of the financial year in cost code 61 Public Protection CCTV would be transferred to the CCTV Earmarked Reserve to provide monies for any future capital costs, as agreed by Full Council. The CCTV cameras were now operating and recording; but would not be monitored until all the contracts had been approved and signed, which should be by the next CCTV meeting on the 29<sup>th</sup> of October.

The Amenities and Projects officer informed members that the large planters when emptied had a layer of polystyrene under the soil, which could have contributed to the poor flowering in some of the planters. The polystyrene could have prevented roots of the plants from absorbing water from the amberol watering system beneath. There had been reports through the summer from members of the public that some of the planters were not doing as well as others.

Councillor Merrick reported that, on speaking to staff at Kehelland Trust, there had been no definitive reason given for the use of the polystyrene.

The Chairman commended the Amenities Projects Officer for his hard work in compiling the comprehensive report.

identified, these were; litter bins, completion of outstanding work on Town Centre benches, refurbishment of the Library noticeboard and the refurbishment of the bus shelter on the junction of Trelowarren Street and Centenary Street.

Members discussed litter bins and the best and most robust material for them for the long term. Councillor Webber stated that if the Town Council took on green spaces more bins would be needed, and that Corey would only empty the number of bins that they are contracted to.

The Town Clerk informed members that due to the increased staffing of the operations team in the winter months the works needed should be achievable

The Town Clerk informed members a contract for works on the Town Clock had been agreed with Mr S Tremayne. The Camborne Christmas lights used the same electrical feed as the Town Clock, and last year a problem with the lights shorted the power supply; it was needed to isolate the power supply to prevent this happening in future. Numerous attempts to contact Mr Tremayne had been unsuccessful in view of this and the fact that the Christmas lights switch on was on 21st November, the Amenities Officer had contacted another trusted local company for a quotation for the works needed on the Town Clock. The work was of a specialist nature and needed

to be done urgently to prevent the problems experienced last year which had damaged the clock mechanism.

The Amenities Officer sought quotes from numerous sources but the only company able to quote for all the maintenance works was Cormac Solutions.

Members discussed at length the issue of the bamboo problem at the Spinney. The Town Clerk explained to members that specialist contractors would be needed to remove the bamboo, at great expense. The Spinney Group had limited funds, only a few members (many of whom were aging) and needed support and help.

The Head Teacher of St Meriadoc School had requested that the sound system be extended further down Trelowarren Street; after discussion members decided not to extend the sound system because of the significant additional cost.

Members were agreed that, as Mr Waters did such a good job as last year's Santa that he be requested to do it again this year should the Deputy Mayor not be able to due to health reasons.

Asking for his help to get this changed; Clare Moody MEP, to ask if she can help with the problem of sewage outflows and inadequate infrastructure and for an update on the new Bathing Water Standards; Cornwall Council, South West Water, and the Environment Agency expressing our objections to the situation and asking**
