After lengthy discussion, in which specifications, support, response times and cost were considered, it was proposed that the Council accepts the quotation offered by Microtest.

The Draft Budget takes into account the staffing recommendations that staff pay figures should be adjusted by 2% to allow for national recommendations and makes allowance for ICT spending. After a lengthy discussion the Committee agreed to recommend to Full Council that the Precept is increased by 3%, to £941,779.
